## **News from First UMC - Austin**

#### **FUMC MEMBERS ADOPT MARRIAGE RESOLUTION**

On September 24, members of First United Methodist Church of Austin adopted a resolution to discontinue marriage ceremonies at its facilities in order to align its wedding policies with its strongly-held principle of full inclusion of all persons. This resolution creates a policy that treats weddings of opposite-sex and same-sex couples equally but does not violate The Book of Discipline. The measure was approved by 93% of the nearly 300 members present and voting. As a result of this policy change, FUMC clergy will not officiate at opposite-sex or same-sex weddings, but can offer a blessing, prayer, or homily. No marriage ceremonies will be allowed in FUMC-Austin facilities after December 31, 2017.

Following the vote, the Board of Trustees will draft an official wedding policy to reflect this change. FUMC will continue to work with other UMC congregations in Texas and beyond to advocate for change in United Methodist Church policies that discriminate against LGBTQ persons.



#### **Scheduled Executions**

The State of Texas is scheduled to execute three people this month:

- On October 12, Robert Pruett is scheduled to be put to death for the murder of Corrections Office Daniel Nagel in the McConnell Unit in Beeville, Texas in 1999. Pruett has steadfastly maintained his innocence. No physical evidence connects him with the crime, and recent DNA analysis of the murder weapon revealed a DNA profile belonging neither to Pruett nor to Officer Nagle. Pruett has faced six execution dates in the past five years. <a href="Take-Action:">Take Action:</a> Contact Governor Abbott and the Texas Board of Pardons and Paroles to stop the execution of Robert Pruett.
- On October 18, Anthony Shore is scheduled to be put to death for multiple murders in Harris County. Sentenced in November 2004, Shore is the last white defendant to receive a death sentence in Harris County. If it proceeds, his execution would be the first out of Harris County this year. <u>Harris County</u> accounts for 127 executions since 1982 (more than any state except Texas).

 On October 26, <u>Clinton Young</u> is scheduled to be put to death for the murders of Doyle Douglas and Samuel Petrey in 2001 in Midland County. He is currently the only Midland County offender on death row.

Texas accounts for 5 out of the 18 executions nationwide thus far in 2017. Currently, there are three additional executions scheduled in Texas in the remaining months of 2017.






